**Purpose.** The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

**Applicability.** The Form HUD-50075-SM is to be completed annually by **Small PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, HCV-Only PHA, or Qualified PHA do not need to submit this form.

**Definitions.**

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

Oyster Bay Avenue in Bremerton that is just under one acre. It is unable to be used due to ground contamination. BHA has hired an attorney to determine financial liability for clean-up and whether there is other funding available to assist with clean-up. If it’s possible to clean up the property and develop it for use by BHA, BHA will pursue that option. If not, BHA will attempt to sell the property. HUD has no interest in this property. The property is fenced with no access.</p> <p>BHA is exploring the development of a portion of the 300 Faircloth units available from the Westpark redevelopment. If BHA decides to develop new units, they would be built initially as public housing units with a plan to convert them at a later date to PBV or PBRA. There is no determination yet about moving forward with this process. If BHA does move forward, the work in FY2024 would be planning, design and submission of applications.</p>

	<p>BHA is researching repositioning possibilities for its entire portfolio. We are in the very early stages of this process and anticipate that applications for funding and HUD approval to reposition 8 properties may be submitted by September 30, 2023. The properties with public housing that would be included in the repositioning are:</p> <ul style="list-style-type: none"> <li>• Winfield (WA003000007) which includes 4 buildings (2 duplexes, 1 8-unit apartment building and 1 12-unit apartment building) for a total of 24 units. There are 2 one-bedroom units, 21 two-bedroom units, and 1 three-bedroom unit at this property. All of these units are public housing.</li> <li>• Wright Court (WA003000013) which includes 8 buildings with a total of 13 units. Six of the 13 units are Public Housing. Of these six, three are 1-bedroom and 3 are 2-bedroom.</li> <li>• Shadow Creek (WA003000008) which includes 4 buildings for a total of 32 units. Of the 32 units, 15 are Public Housing. All 15 are 2-bedroom units.</li> <li>• Charter House (WA003000009) which is one elevator building that has been designated elderly. There are 30 units in this building. Of those 30, twelve are Public Housing. All 11 units are 1-bedroom units.</li> <li>• Casa Del Sol (WA003000012) is one elevator building with 18 units. Of those 18, six are Public Housing and all of those are 1-bedroom units.</li> </ul> <p>BHA currently has three units that have been approved by HUD as a vacant unit undergoing modernization. BHA plans to modernize 2 to 5 units as funding becomes available.</p> <p>(c) If using Project-Based Vouchers, provide the projected number of project-based units, general locations, and describe how project-basing would be consistent with the PHA Plan.</p> <p>The Bremerton Housing Authority is aware of several existing and new construction projects that are interested in obtaining project-based vouchers for their units. BHA anticipates issuing a Request for Proposals for Project Based Vouchers in the winter of 2023. We anticipate that up to 50 project-based vouchers will be made available in that RFP to existing and new construction projects in Kitsap County. Project-basing units is consistent with BHA's Annual Plan since it increases affordable housing opportunities by attaching subsidy to units that were previously or might have become market rate.</p> <p>(d) The PHA must submit its Deconcentration Policy for Field Office Review.</p>

A PHA will be considered in compliance with the certification requirement to affirmatively further fair housing if the PHA fulfills the requirements of §§ 903.7(o)(1) and 903.15(d) and: (i) examines its programs or proposed programs; (ii) identifies any fair housing issues and contributing factors within those programs, in accordance with 24 CFR 5.154; or 24 CFR 5.160(a)(3) as applicable (iii) specifies actions and strategies designed to address contributing factors, related fair housing issues, and goals in the applicable Assessment of Fair Housing consistent with 24 CFR 5.154 in a reasonable manner in view of the resources available; (iv) works with jurisdictions to implement any of the jurisdiction's initiatives to affirmatively further fair housing that require the PHA's involvement; (v) operates programs in a manner consistent with any applicable consolidated plan under 24 CFR part 91, and with any order or agreement, to comply with the authorities specified in paragraph (o)(1) of this section; (vi) complies with any contribution or consultation requirement with respect to any applicable AFH, in accordance with 24 CFR 5.150 through 5.180; (vii) maintains records reflecting these analyses, actions, and the results of these actions; and (viii) takes steps acceptable to HUD to remedy known fair housing or civil rights violations. impediments to fair housing choice within those programs; addresses those impediments in a reasonable fashion in view of the resources available; works with the local jurisdiction to implement any of the jurisdiction's initiatives to affirmatively further fair housing; and assures that the annual plan is consistent with any applicable Consolidated Plan for its jurisdiction. (24 CFR §903.7(o)).

Furthermore, under Section 5A(d)(15) of the U.S. Housing Act of 1937, as amended, a PHA must submit a civil rights certification with its Annual PHA Plan, which is described at 24 CFR 903.7(o)(1) except for qualified PHAs who submit the Form HUD-50077-CR as a standalone document.
