Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. Form HUD-50075-SM is to be completed annually by **Small PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, HCV-Only PHA, or Qualified PHA do not need to submit this form.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, or at risk of being designated as troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment, and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

B.3	<p>Progress Report.</p> <p>Provide a description of the PHA's progress in meeting its Mission and Goals described in the PHA 5-Year Plan.</p> <p>BHA senior staff have attended technical assistance trainings from HUD in regards to BHA's plan to reposition the public housing units. BHA would also like to consider homeownership as part of the conversion if BHA can find a way to relocate the subsidy from the previous RAD conversion to another site.</p> <p>Sound Communities, BHA's non-profit, was used in November and December of 2020 to raise funds for holiday-related activities and gifts for BHA's tenants. BHA intends to submit two grant applications in 2021 to private foundations to support funding operations for Bay Vista Commons, BHA's assisted living facility, and a service coordinator position to assist BHA's elderly tenants to age in place.</p> <p>With the announcement of new Emergency Housing Choice Vouchers, BHA will be adding a homeless preference to the waitlist. The HCV waitlist was just opened to the general population. Based on the outcome of that waitlist process, BHA may consider opening the waitlist to create a preference for "homeless" to meet requirements of the implementation of the emergency vouchers.</p>

BHA opened the Housing Choice Voucher waitlist in March of 2021. We are adding 600 applicants to the waitlist. The goal is to lease up as many as possible over the 24 months to ensure our status as a high performer.

In hopes of having many successful applicants approved and looking for housing, BHA plans to add an owner liaison position to the team. This position will be the link between the housing department and landlords. We also intend on creating an orientation video and updating the landlord guide handbook to help with orientation the program.

BHA awarded 61 vouchers in 2020, to Kitsap Mental Health for a housing first building currently under construction, the vouchers are slated to be leased up in March of 2022.

BHA is in talks with the VA and a developer out of Mason County. The owner/operator, Quixote Communities is looking for PVB's for a project that will be made up of 7 four plex's and 1 duplex for a total of 30 units.
